## Terms and Conditions

**Preamble:** This Policy evidences a contract between You and Us and has been issued on the basis of Your statements and declarations in the Proposal Form and other documents evidencing insurability of the Life Assured. Reference to any legislation, Act, regulation, guideline, etc includes subsequent changes or amendments to the same. The terms 'You', 'Your' used refer to the Policyholder and 'We', 'Us', 'Company', 'Our' refer to Canara HSBC Life Insurance Company Limited. The word "Authority" would refer to the Insurance Regulatory and Development Authority of India.

## PART B - Glossary of Important Terms

**Age** means Life Assured's age at his/her last birthday, as on Policy Commencement Date.

**Annualized Premium** means the Premium payable in a year chosen by the Policyholder, excluding the taxes, rider premiums, underwriting extra premiums and loadings for modal premiums, if any.

**Assignee** means the person to whom the rights and benefits of the Policy are transferred/assigned by You.

**Claimant** means the Policyholder or Assignee, however for the purposes of payment of benefit upon the death of the Life Assured, Claimant means the following person(s):

- i. Where the Policyholder and Life Assured are different, Claimant will be the Policyholder;
- ii. Where Policyholder and Life Assured are same, Claimant will be the Nominee(s);
- iii. Where Policyholder and Life Assured are same and there is no Nominee(s), then Claimant shall be the Policyholder's legal heir or legal representative or the holder of a succession certificate.

**Financial Year** means a period of 12 months commencing from April 1st every year.

**G-Sec** means Government Security which is a tradable instrument issued by the Central Government or the State Governments.

**Grace Period** means the time granted by Us from the due date for payment of Premium without any penalty/ late fee, during which time the Policy is considered to be in-force with risk cover.

**Guaranteed Cash Back** is the survival benefit payable under the Guaranteed Cash Back Option. The Guaranteed Cash Back amount is equivalent to 15% of Guaranteed Sum Assured on Maturity and is payable from the end of 5<sup>th</sup> Policy Year and at the end of every 5<sup>th</sup> Policy Year thereafter (before the end of the Policy Term) provided the Life Assured is alive at the end of each such period. The following table summarizes the timing and amount of each Guaranteed Cash Back for different Policy Terms:

\*GSAM is Guaranteed Sum Assured on Maturity as defined below

**Guaranteed Sum Assured on Maturity** means the sum of Annualized Premiums payable under the Policy during the Premium Payment Term (i.e. Annualized Premium x Premium Payment Term)

**Guaranteed Yearly Additions** means the benefit which accrues at the beginning of each Policy Year in the last three (3) years of the Policy Term. These Guaranteed Yearly Additions will be calculated as a percentage of cumulative Annualised Premium paid till date and vary by Plan Option, Entry Age of the Life Assured, Premium Band, Premium Payment Term and Policy Term. For Paid-up policies, these percentages will be equal to 50% of the percentages applicable to in-force policies. These Guaranteed Yearly Additions are provided in the Annexure 7.

**Lapsed State** means the state of the Policy where You fail to pay due Premium within the Grace Period in the first 2 consecutive Policy Years.

**Life Assured** means the person named in the Policy Schedule whose life is insured under the Policy.

**Nominee(s)** means the person(s) named in the Policy Schedule who is/are entitled to receive the benefits upon the death of the Life Assured

**Paid-up State** means the state of the Policy where You fail to pay due Premiums within the Grace Period after payment of Premiums for at least first 2 consecutive Policy Years, in which state no further Premiums are payable and benefits are reduced as per the terms and conditions of the Policy.

**Paid-up Sum Assured on Death** is defined as the ratio of ("Number of Premiums paid" to "Total number of Premiums payable during the Policy Term") multiplied by the Sum Assured on Death.

**Paid-up Guaranteed Sum Assured on Maturity** means the ratio of ("Number of Premiums paid" to "Total number of Premiums payable during the Policy Term") multiplied by the Guaranteed Sum Assured on Maturity.

**Paid-up Guaranteed Cash Back** is defined as the ratio of ("Number of Premiums paid" to "Total number of Premiums payable during the Policy Term") multiplied by the Guaranteed Cash Back.

**Policy** means this contract of insurance entered between You and Us as evidenced by the Policy Document.

**Policyholder** means the person named in the Policy Schedule who is the owner of the Policy.



**Policy Anniversary** means the date corresponding to the Policy Commencement Date occurring after the completion of every Policy Year.

**Policy Document** means and includes terms and conditions, the attached Policy Schedule, the Proposal Form and all endorsements issued by Us from time to time.

**Policy Year** means the 12 consecutive months' period commencing from the Policy Commencement Date and each subsequent period of 12 consecutive months thereafter during the Policy Term, which may be different from calendar year.

**Premium** means the amount payable by You to Us, as specified in the Policy Schedule as "Installment Premium" in exchange for Our obligation to pay the benefits under the Policy. Premium excludes any applicable Goods and Services Tax or any other levy by whatever name called under Goods and Services Tax Scheme.

**Proposal Form** means an application form along with any other statements or declarations required by Us which is duly completed and submitted to Us by the Proposer for issuance of the Policy.

**Revival** means restoration of a Policy in Lapsed State or in Paid-up State to in-force status subject to terms and conditions of the Policy.

**Revival Period** means a period of 5 consecutive years from the due date of first unpaid installment of Premium, during which period You will be entitled to revive the Policy in Lapsed State or in Paid-up State.

**Sum Assured** means an absolute amount assured to be paid on death which is equal to Annualized Premium multiplied by the Death Benefit Factor, where the Death Benefit Factor varies by the age at entry of the Life Assured and is as given in Annexure 6.

**Sum Assured on Death**— means higher of: i. 11 times the Annualized Premium; or ii 105% of Total Premiums Paid, or iii. Guaranteed Sum Assured on Maturity; or iv. Sum Assured

**Surrender Value** means the amount payable to You in the event of termination / surrender of the Policy, subject to terms and conditions of the Policy.

**Total Premiums Paid** means total of all the Premiums received, excluding rider premiums, underwriting extra premiums and taxes.

**Underwriting** means the process of evaluating risks for insurance and determining on what terms We will accept the risk as per Our board approved underwriting policy.

The capitalized terms used but not defined will derive their meaning from the Policy Schedule.

## PART C

### 1. Benefits

Subject to terms and conditions below, We agree to pay to the Claimant, any of the following benefits based upon the Plan Option chosen by You. The Plan Option once chosen cannot be changed during the Policy Term.

#### 1.1 Maturity Benefits

##### 1.1.1 Plan Option - Guaranteed Savings Option:

- a) Upon survival of Life Assured till the end of the Policy Term and where the Policy is in-force, We will pay the following benefits upon the maturity of the Policy, after deducting outstanding loan amounts including interest, if any:
  - i. Guaranteed Sum Assured on Maturity; plus
  - ii. Accrued Guaranteed Yearly Addition(s).
- b) Upon survival of Life Assured till the end of the Policy Term and where the Policy is in Paid-up State, We will pay the following benefits upon the maturity of the Policy after deducting outstanding loan amounts including interest, if any:
  - i. Paid-up Guaranteed Sum Assured on Maturity; plus
  - ii. Accrued Guaranteed Yearly Addition(s),.
- c) On payment of benefits under either 1.1.1 (a) or 1.1.1 (b), the Policy shall immediately and automatically terminate and no further benefit shall be payable.

##### 1.1.2 Plan Option - Guaranteed Cash Back Option:

- a) Upon survival of Life Assured till the end of the Policy Term and where the Policy is in-force, We will pay the following benefits upon the maturity of the Policy after deducting outstanding loan amounts including interest, if any:
  - i. Guaranteed Sum Assured on Maturity, less Survival Benefit already paid, if any, plus
  - ii. Deferred Survival Benefit, if any; plus
  - iii. Accrued Guaranteed Yearly Addition(s)
- b) Upon survival of Life Assured till the end of the Policy Term and where the Policy is in Paid-up State, We will pay the following benefits upon the maturity of the Policy after deducting outstanding loan amounts including interest, if any:
  - i. Paid-up Guaranteed Sum Assured on Maturity, less Survival Benefit already paid, if any, plus
  - ii. Deferred Survival Benefit, if any, plus
  - iii. Accrued Guaranteed Yearly Addition(s),
- c) On payment of benefits under either 1.1.2(a) or 1.1.2 (b), the Policy shall immediately and automatically terminate and no further benefit shall be payable.



## **1.2 Death Benefit**

### **CARE Pay Benefit:**

This benefit shall be applicable under both Guaranteed Savings Option and Guaranteed Cash Back Option for an in-force Policy. Under this benefit 100% of Total Premiums Paid till date of Death shall be paid in advance to the Nominee on intimation of death of the Life Assured. This is an accelerated cover and the amount paid for this benefit will be deducted from the Sum Assured on Death payable.

This benefit will be considered only once the death of the Life Assured is established basis the death certificate issued by competent authority and the rights of the Claimant is established basis the Nominee KYC, subject to receipt of NEFT details of Claimant, filled claim Form, Death Certificate and Policy Contract. The list of documents required to avail this Benefit may change subject to prior intimation. We will pay the Care Pay benefit to the Claimant within 2 working days from date of receipt of the applicable Claim documents as mentioned above.

#### **1.2.1 Plan Option - Guaranteed Savings Option:**

On death of the Life Assured and where the claim is admitted, We will pay the benefits as detailed below subject to the Suicide Exclusion after deducting outstanding loan amounts including interest, if any:

- a) If the death of the Life Assured occurs during the Policy Term while the Policy is in-force at the time of death, we will pay the following:
  - i. Sum Assured on Death less CARE Pay Benefit already paid, if any; plus
  - ii. Accrued Guaranteed Yearly Addition(s), if any.
- b) If the death of the Life Assured occurs during the Policy Term while the Policy is in Paid-up State, We will pay the following:
  - i. Paid-up Sum Assured on Death; plus
  - ii. Accrued Guaranteed Yearly Addition(s), if any.
- c) On payment of benefit under either 1.2.1 (a) or 1.2.1 (b), the Policy will immediately and automatically terminate and no further benefit will be payable.

#### **1.2.2 Plan Option - Guaranteed Cash Back Option:**

On death of the Life Assured and where the claim is admitted, We will pay the benefits as detailed below subject to the Suicide Exclusion after deducting outstanding loan amounts including interest, if any:

- a) If the death of the Life Assured occurs during the Policy Term while the Policy is in-force at the time of death, we will pay the following:
  - i. Sum Assured on Death less CARE Pay Benefit already paid, if any; plus
  - ii. Deferred Survival Benefit, if any, plus
  - iii. Accrued Guaranteed Yearly Addition(s), if any.
- b) If the death of the Life Assured occurs during the Policy Term while the Policy is in Paid-up State at the time of death, We will pay the following:
  - i. Paid-up Sum Assured on Death; plus
  - ii. Deferred Survival Benefits, if any, plus
  - iii. Accrued Guaranteed Yearly Addition(s), if any.
- c) On payment of benefit under either 1.2.2 (a) or 1.2.2 (b), the Policy will immediately and automatically terminate and no further benefit will be payable.

## **1.3 Survival Benefit**

### **1.3.1 Plan Option - Guaranteed Savings Option:**

Not Applicable

### **1.3.2 Plan Option - Guaranteed Cash Back Option:**

Upon survival of the Life Assured at regular intervals defined as per the terms and conditions of the Policy, the Survival Benefit will be paid:

- a) Upon survival of Life Assured during the Policy Term and the Policy is in-force and all due Premiums are paid, the Survival Benefit payable is Guaranteed Cash Back.
- b) Upon survival of Life Assured during the Policy Term and the Policy is in Paid-Up State, the survival benefit payable is Paid-up Guaranteed Cash Back.

Option of Deferring Survival Benefits (Applicable for Guaranteed Cash Back Option only)

The Policyholder has an option to defer the payout of Survival Benefits to the end of the Policy Term. The deferred guaranteed Survival Benefit will be accumulated at a non-participating accumulation rate which shall be calculated as the 10 Year G-Sec published by CRISIL (as at 31st December every year) less 2.0% (floored at 0%), which shall be applicable over the following financial year. The applicable interest rate for the financial year 2022-23 is 4.46% per annum compounded annually.

The Policyholder can choose to opt in or opt out of this option at any point during the Policy Term by giving the Company a written notice at least 30 days before the next Survival Benefit due date, as applicable. The Policyholder can withdraw his / her balance money from accumulated Survival Benefit partially/fully any time during the Policy Term by giving the Company a written notice.

Upon death of the Life Assured or upon surrender/maturity of the Policy, the deferred Survival Benefit, if not withdrawn already, shall be payable along with the Death Benefit, Surrender Benefit or Maturity Benefit as applicable.

**1.4** If the death of the Life Assured occurs during the Grace Period and the claim is admitted, We will deduct due unpaid Premium(s), if any, along with applicable Goods and Services Tax or any other levy by whatever name called under Goods and Services Tax Scheme, if any, before paying the benefits, subject to the Suicide Exclusion.

**1.5 Requirements for Death Benefit Claims:** Refer Claims Procedures mentioned under Clause 19 in Part F.

## **2. Premiums**

**2.1 Payment of Premiums:** You will pay Premium at the frequency as specified by the Premium Payment Mode and for such Premium Payment Term as indicated in the Policy Schedule at the respective due dates or before the end of Grace Period. If any Premium is received before the due date, We may keep such amount in an advance premium account and adjust such sum towards Premium on the applicable due date or refund such amount to You. Collection of advance Premium shall be allowed within the same financial year for the Premium due in that financial year. However, where the Premium due in one financial year is being collected in advance in earlier financial year, the Company may collect the same for a maximum period of three months in advance of the due date of the premium. Such advance premium if any paid by You will not carry any interest. You are not permitted to change the Premium Payment Term during the Policy Term. **2.2 Change in Premium Payment Mode:** The Premium Payment modes available under the Product are given in Section 8.8 below. The Policyholder may change the premium payment mode anytime during the Premium Payment Term however the same shall be effective from the subsequent Policy Anniversary date, subject to application of modal factors. The request should be made at least 60 days prior to the Policy Anniversary from which the change will be effective. There is no fee on such alteration. **2.3 Non-payment of Premium:** If the Policy is in Lapsed State (refer to Part B) no benefit shall be payable upon death or upon Your request for termination/surrender of the Policy or on the expiry of the Revival Period. If a Policy in Lapsed State is not revived within the Revival Period, it shall terminate upon expiry of the Revival Period. However, if the Policy in Paid-up State is not revived within the Revival Period, then the Policy shall continue as per the terms and conditions of the Policy until a valid request of Surrender is submitted to Us. **2.4 Grace Period:** You are required to pay Premium on or before the Premium payment due date. However, You are provided with a Grace Period, of 15 days for monthly mode and 30 days for all other modes, i.e. annual, half yearly and quarterly modes from Premium due date to pay due Premium.

## **PART D**

### **3 Surrender**

**3.1** You may surrender the Policy anytime and the Policy acquires Guaranteed Surrender Value (as defined below) or Special Surrender Value (as defined below) after payment of Premiums for at least first 2 consecutive Policy Years.

#### **Guaranteed Savings Option:**

a) Guaranteed Surrender Value is defined as:

Factor "A" X Total Premiums Paid plus Factor "B" X accrued Guaranteed Yearly Additions, if any

Where Factor "A" and Factor "B" are provided in the Annexure 8. Factor A and Factor B are guaranteed for the entire Policy Term.

b) Special Surrender Value is defined as:

Factor "C" X (Paid-up Guaranteed Sum Assured on Maturity plus accrued Guaranteed Yearly Additions, if any)

Factor "C" is provided in the **Annexure 8** and may be revised in the future with the prior approval of the Authority.

The Surrender Value payable shall be higher of Guaranteed Surrender Value (GSV) or Special Surrender Value (SSV) and will be paid after deducting outstanding loan amounts including interest, if any.

#### **Guaranteed Cash Back Option:**

a) Guaranteed Surrender Value up to the Policy Term is defined as: Maximum [0, (Factor "A" X Total Premiums Paid plus Factor "B" X accrued Guaranteed Yearly Additions, if any, less total Survival Benefits already paid, plus deferred Survival Benefit, if any)]

Where Factor "A" and Factor "B" are provided in the **Annexure 8** and are guaranteed for the entire Policy Term.

b) Special Surrender Value is defined as:

Maximum [0, {C X (Paid-up Guaranteed Sum Assured on Maturity plus accrued Guaranteed Yearly Additions, if any) less total Survival Benefits already paid plus deferred Survival Benefit, if any}]

Factor "C" is provided in the Annexure 8 and may be revised in the future with the prior approval of the Authority.

The above mentioned formula is applicable for in-force as well as reduced/fully paid up policies.

The Surrender Value payable shall be higher of Guaranteed Surrender Value (GSV) or Special Surrender Value (SSV), subject to minimum of zero and will be paid after deducting outstanding loan amounts including interest, if any.

**3.2** We shall on receipt of a valid request for surrender, pay the Surrender Value, if any, and the Policy shall terminate and no further benefits shall be payable.

#### 4. Revival:

You may revive the Policy in Lapsed State or Paid-up State by giving Us a request and paying all due unpaid installments of Premium with interest at the rate specified by Us subject to completing other requirements as may be stipulated by Us, within the Revival Period (refer to Part B) and during the Policy Term provided no claim has arisen under the Policy due to the death of the Life Assured. You shall provide the evidence of insurability and health of the Life Assured to Our satisfaction. We reserve the right to Revive the Policy either on its original terms or on modified terms as per our Underwriting policy, which decision will be final and binding on You. The Revival will be effective from the date when We communicate the same to You. In case the request for Revival is rejected, the Premium including interest paid for the Revival would be refunded to You. On Revival, the benefits including Guaranteed Yearly Addition(s), if any, shall be reinstated, which were not accrued during the Revival Period) and all other benefits would be reinstated as per the terms & conditions of the Policy. Further, excess of any Survival Benefits (if any) payable to a premium paying Policy during the Revival Period over the Survival Benefits already paid during this period, will be paid immediately on revival. The basis for determining the interest rate, on simple interest basis, is the average of the daily rates of 10-Year G-Sec rate over the last five calendar years ending 31st December every year rounded to the nearest 50 bps plus a margin of 200 bps, where 1 bps is equal to 0.01%. Any change in the basis of this interest rate will be subject to the prior approval of the Authority. The Company undertakes the review of the interest rates for revivals on 31st December every year with any changes resulting from the review being effective from the 1st of April of the following year. The applicable interest rate for the financial year 2022-23 is 9 % per annum.

#### 5. Policy Loan:

**5.1** You may apply for a loan as per loan application terms and conditions, subject to the following conditions: **a)** the Policy should have been in-force while applying for a loan. **b)** the Policy should have acquired Surrender Value as per Clause 3 of Part D. **c)** the Policy should not have been in Paid-up State. **d)** 100% of deferred Survival Benefit, if any, shall be utilized under the Policy. **5.2** The loan facility available under the Policy, where granted will be repayable with interest chargeable from the date of disbursement of the loan at the interest rate specified by Us. The basis / formula for determining the loan interest rate is (5 Year Constant G-Sec Yield + 150 bps, rounded down to the nearest 10 bps) % p.a. Interest compounding will happen on Policy Anniversary. Any change in basis of determination of interest rate for Policy Loan will be subject to prior approval of the Authority. The Company undertakes the review of the interest rate for Policy loans on 31st December every year with any changes resulting from the review being effective from the 1st of April of the following year. The applicable interest rate for the financial year 2022-23 is 7.3% per annum compounded annually.

A loan disbursement letter will be issued informing about the loan details including the applicable interest rate and relevant terms thereof. The Policy shall be assigned to Us on disbursement of the loan and the original Policy Document will be submitted to Us till repayment of outstanding loan amount including interests thereon, if any. The loan facility will also be subject to the following conditions: **a)** The minimum loan amount disbursed shall be ₹20,000. **b)** The maximum loan amount will not exceed 80% of the Surrender Value as applicable on the date of disbursement of the loan, after utilizing 100% of the Deferred Survival Benefit (if any). The option to defer any Survival Benefits in the future shall be withdrawn post availing loan and shall be only reinstated post full repayment of Loan, including interest. **c)** The minimum repayment amount will be ₹2,000/- or outstanding loan amount including outstanding interest, if any, whichever is lower. **d)** The maximum repayment amount will be equal to outstanding loan amount including outstanding interest, if any. **e)** The maximum tenure of the loan shall be up to the outstanding Policy Term. However, You will have the option to foreclose the loan anytime during the Policy Term by paying the outstanding loan amount and interest thereon. **f)** We reserve the right to recover the outstanding loan and interest thereon by deduction from the benefits payable in case of Death, Surrender, Maturity or Survival (including any CARE Pay Benefit) payable. Only the balance amount, if any shall be payable or be available for deferring the Survival Benefit (where applicable). **g)** If at any point in time, for other than in-force and fully Paid-up Status Policies: If the outstanding loan amount including outstanding interest is greater than or equal to the Surrender Value payable under the Policy and the Policyholder fails to repay the outstanding loan including outstanding interest after being given intimation of 3 months (or the timeline as applicable as per Company policy at that point in time) and reasonable opportunity to continue the Policy, the Policy will be foreclosed and all rights and benefits under the Policy will stand ceased. For in-force or fully paid-up policy: Policy cannot be foreclosed on the ground of outstanding loan amount including interest exceeds the Surrender Value. At the end of the Policy Term, in case the loan amount including outstanding interest is not repaid by the Policyholder, then the benefit payable on Maturity less the loan amount including outstanding interest shall be paid to the Policyholder and the Policy will be terminated.

#### 6. Termination of Policy:

The Policy will terminate upon happening of any one of the following events: **a)** on the date on which We receive a valid free-look cancellation request from You; **b)** on the date of intimation of repudiation of the claim in accordance with the terms and conditions of the Policy; **c)** in case of misstatement of Age, fraud and mis-statement in accordance with Clauses 14 and 22 in Part F; **d)** as mentioned in Clauses 1,2,3, 4 and 5.

#### 7. Ownership:

All options, rights and obligations under the Policy vest with You and will be discharged by You.

**8. Free-look period:** In case the Policy terms and conditions are not agreeable to You then You can opt for a cancellation of the Policy, in which case, We request You to send back this Policy Document along with the reason for Your objection within 15 days (30 days in case the Policy is sourced through electronic or distance marketing mode) from the date of receipt of this Policy Document. In case You opt for cancellation within the said period, We shall refund the Premium received by us subject only to deduction of the proportionate risk Premium for the period of life cover, stamp duty and medical expenses, if any. Please note that this facility is available only on receipt of the original Policy Document, and will not apply to duplicate Policy Document issued by the Company on your request.

## **PART E**

**9. Charges:** There are no explicit charges under this Policy.

## **PART F - General Conditions**

### **10. Assignment:**

Assignment should be in accordance with provisions of Section 38 of the Insurance Act 1938, as amended from time to time. The entire Section 38 is reproduced and enclosed in **Annexure 3**.

### **11. Nomination:**

Nomination should be in accordance with provisions of Section 39 of the Insurance Act 1938, as amended from time to time. The entire Section 39 is reproduced and enclosed in **Annexure 4**.

### **12. Amendment:**

We reserve the right to alter or delete any of the terms and conditions of the Policy, including the benefits with prior approval of the Authority. The terms of the Policy will also stand modified from time to time, to the extent of changes in applicable laws or regulations affecting the terms and conditions of the Policy.

### **13. Policy Currency:**

All Premiums and benefits payable shall be paid in Indian Rupees only.

### **14. Misstatement of Age:**

The Age of the Life Assured is derived basis Your declaration in the Proposal Form and/or other supporting document/proof in this regard. Due to misstatement of Age if You have paid less Premium(s) than what was payable for the correct age, We are entitled to charge and You are obliged to pay for such Premium difference since the Policy Commencement Date without interest. In case of termination of the Policy any unpaid balance will be adjusted from the benefit payout. If the date of birth of the Life Assured has been misstated resulting in higher Premium(s) paid by You than what was payable for the correct age, We will refund the excess Premiums without any interest. If at the correct Age, the Life Assured was not insurable according to our requirements, We reserve the right to pay the Premiums paid till date post deduction of any relevant cost, expenses or charges as applicable and terminate the Policy in accordance with Section 45 of the Insurance Act, 1938, as amended from time to time.

### **15. Compliance with Laws:**

You will be responsible to comply with all applicable laws including regulations or taxation laws and payment of all applicable taxes in respect of the Premium, charges and benefits or other payouts made or received under the Policy. We are entitled to make such deductions and/or levy such charges, present and/or future which in Our opinion are necessary and appropriate, from and/or on the Premium(s) payable or charges or benefits under the Policy on account of any income tax, withholding tax, Goods and Services Tax or other tax, cess, duty or other levy which is or may be imposed in relation to the Policy under any applicable law or otherwise upon Us, You or the Claimant. We will not be liable for any taxes on any of Your or Claimant's personal income. You are responsible for complying with Your tax obligations (including but not limited to, tax payment or filing of returns or other required documentation relating to the payment of all relevant taxes in all jurisdictions in which Your tax obligations arise and relating to the services provided by Us). We do not provide any tax related advice and You are advised to seek an independent legal and/or taxation advice.

### **16. Communication and Dispatch:**

We will send you the policy document in accordance with the applicable laws. We will send the communication or notices to you either in physical or electronic mode (including sms) at your registered address/email id or registered mobile number provided by you in proposal form or otherwise notified to us. Any change in the registered address /email or registered mobile number of Policyholder or Claimant must be notified to Us immediately.

### **17. Replacement of Policy Document:**

We will replace a lost Policy Document subject to making investigations. If We replace the lost Policy Document, then: i. the original Policy Document will cease to be applicable and You agree to indemnify Us from any and all losses, claims, demands or damages arising from or in connection with the original Policy Document. ii. You will not be entitled to any free-look period cancellation on the duplicate Policy Document issued. However, We may permit free-look period cancellation in cases where after investigation, it is evident that You did not receive the original Policy Document. iii. No charge/fee will be levied for replacement of Policy Document.

### **18. Exclusions: Suicide Clause:**

If the Life Assured, whether sane or insane, commits suicide within 12 months from the Risk Commencement Date under the Policy (provided the Policy is in force) or date of Revival of the Policy, the Nominee of the Policyholder shall be entitled to an amount which is higher of 80% of the Total Premiums Paid till the date of death or the Surrender Value available as on the date of death.

Upon such payments, the Policy will immediately and automatically terminate and no further benefit will be payable under the Policy.

### **19. Claim Procedures:**

**Maturity Claim Procedure:**

In case of Maturity Benefit payout, following documents are required by us to process the claim: **a)** Bank Account details for money transfer (in case the same are not updated), **b)** With respect to NRI/NR customers, documentation on FEMA compliance or such applicable law, **c)** Any other documents including KYC as may be required.

**Death Claim Procedure:**

In the event of death, to register the claim under the Policy, the Claimant will endeavor to inform Us in writing immediately within a period of 90 days of such death through the Claim Form along with the following documents:

- i. Original Policy Document.
- ii. Death certificate.
- iii. Attested copy of photo identity and address proof of the Claimant.
- iv. Company Specific Claim formats duly completed and signed – Claim Form, Physician's Statement, Treating Hospital Certificate, Employer Certificate.
- v. Hospital records/other medical records.
- vi. Post-mortem / chemical viscera report, wherever conducted.
- vii. Police records including First information report, panchnama, police investigation report and final police report only in case of unnatural or death due to Accident.

If We do not receive the notification of death within 90 days, We may condone the delay if We are satisfied that the delay was for reasons beyond the Claimant's control and pay the claim specified under the Policy to the Claimant. We reserve the right to call for such documents or information, including documents/ information concerning the title of the Claimant, to Our satisfaction for processing the claim. Any change in the address or details above will be communicated by Us to You. Our liability under the Policy will be automatically discharged on payment to the Claimant.

**20. Electronic transactions:**

In conducting electronic transactions, in respect of this Policy, You will comply with all such terms and conditions as prescribed by Us. Such electronic transactions are legally valid when executed in adherence to such terms and conditions and will be binding on You.

**21. Governing Law and Jurisdiction:**

The Policy will be governed by Indian law and the jurisdiction will be that of Indian courts.

**22. Fraud and Mis-statement:**

Fraud and mis-statement would be dealt with in accordance with provisions of Section 45 of the Insurance Act, 1938, as amended from time to time, which provisions are enclosed in **Annexure 5**.

**23. Travel And Occupation:**

There are no restrictions on travel or occupation under this Policy.

**24.4** In case You are not satisfied with the resolution or there is no response within a period of 1 month, You / complainant may approach the Insurance Ombudsman for Your State at the address mentioned below or on Authority's website [www.irdai.gov.in](http://www.irdai.gov.in). if the grievance pertains to the matters as



mentioned below or an appropriate judicial/quasi-judicial authority having jurisdiction over the matter for redressal of Your grievance. You may also refer to the website at <http://www.cioins.co.in/ombudsman.html> for updated list of Ombudsman. The Ombudsman may receive complaints under Rule 13 of Insurance Ombudsman Rules, 2017 ("Rules"); **a)** for any partial or total repudiation of claim by Us; **b)** for any dispute in regard to Premium paid or payable; **c)** for any dispute on the legal construction of the Policy in so far as such dispute relate to claim; **d)** for delay in settlement of claim; **e)** for non-issue of any insurance document after receipt of Premium; **f)** misrepresentation of policy terms and conditions; **g)** policy servicing related grievances against Company and their agents and intermediaries; **h)** issuance of policy which is not in conformity with the proposal form submitted by proposer; and **i)** any other matter resulting from the violation of provisions of Insurance Act, 1938 or regulations, circulars, guidelines or instructions issued by Authority from time to time or terms and conditions of the policy in so far as they relate to issues mentioned above.

**24.5** As per provision 14(3) of the Rule:- No complaint to the Insurance Ombudsman shall lie unless—**(a)** the complainant makes a written representation to the insurer named in the complaint and—**(i)** either the insurer had rejected the complaint; or **(ii)** the complainant had not received any reply within a period of one month after the insurer received his representation; or **(iii)** the complainant is not satisfied with the reply given to him by the insurer; **(b)** The complaint is made within one year—**(i)** after the order of the insurer rejecting the representation is received; or **(ii)** after receipt of decision of the insurer which is not to the satisfaction of the complainant; **(iii)** after expiry of a period of one month from the date of sending the written representation to the insurer if the insurer named fails to furnish reply to the complainant. As per provision 14(5) of the Rule:- No complaint before the Insurance Ombudsman shall be maintainable on the same subject matter on which proceedings are pending before or disposed of by any court or consumer forum or arbitrator.

## **Annexure 3**

### **Section 38 “Assignment and Transfer of Insurance Policies” is reproduced below**

**1.** A transfer or assignment of a policy of insurance, wholly or in part, whether with or without consideration, may be made only by an endorsement upon the policy itself or by a separate instrument, signed in either case by the transferor or by the assignor or his duly authorised agent and attested by at least one witness, specifically setting forth the fact of transfer or assignment and the reasons thereof, the antecedents of the assignee and the terms on which the assignment is made. **2.** An insurer may, accept the transfer or assignment, or decline to act upon any endorsement made under sub-section (1), where it has sufficient reason to believe that such transfer or assignment is not bona fide or is not in the interest of the policy-holder or in public interest or is for the purpose of trading of insurance policy. **3.** The insurer shall, before refusing to act upon the endorsement, record in writing the reasons for such refusal and communicate the same to the policy-holder not later than thirty days from the date of the policy-holder giving notice of such transfer or assignment. **4.** Any person aggrieved by the decision of an insurer to decline to act upon such transfer or assignment may within a period of thirty days from the date of receipt of the communication from the insurer containing reasons for such refusal, prefer a claim to the Authority. **5.** Subject to the provisions in sub-section (2), the transfer or assignment shall be complete and effectual upon the execution of such endorsement or instrument duly attested but except, where the transfer or assignment is in favour of the insurer, shall not be operative as against an insurer, and shall not confer upon the transferee or assignee, or his legal representative, any right to sue for the amount of such policy or the moneys secured thereby until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or a copy thereof certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer: Provided that where the insurer maintains one or more places of business in India, such notice shall be delivered only at the place where the policy is being serviced. **6.** The date on which the notice referred to in sub-section (5) is delivered to the insurer shall regulate the priority of all claims under a transfer or assignment as between persons interested in the policy; and where there is more than one instrument of transfer or assignment the priority of the claims under such instruments shall be governed by the order in which the notices referred to in sub-section (5) are delivered: Provided that if any dispute as to priority of payment arises as between assignees, the dispute shall be referred to the Authority. **7.** Upon the receipt of the notice referred to in sub-section (5), the insurer shall record the fact of such transfer or assignment together with the date thereof and the name of the transferee or the assignee and shall, on the request of the person by whom the notice was given, or of the transferee or assignee, on payment of such fee as may be specified by regulations, grant a written acknowledgement of the receipt of such notice; and any such acknowledgement shall be conclusive evidence against the insurer that he has duly received the notice to which such acknowledgment relates. **8.** Subject to the terms and conditions of the transfer or assignment, the insurer shall, from the date of the receipt of the notice referred to in sub-section (5), recognize the transferee or assignee named in the notice as the absolute transferee or assignee entitled to benefit under the policy, and such person shall be subject to all liabilities and equities to which the transferor or assignor was subject at the date of the transfer or assignment and may institute any proceedings in relation to the policy, obtain a loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to such proceedings. Explanation.— Except where the endorsement referred to in sub-section (1) expressly indicates that the assignment or transfer is conditional in terms of sub-section (10) hereunder, every assignment or transfer shall be deemed to be an absolute assignment or transfer and the assignee or transferee, as the case may be, shall be deemed to be the absolute assignee or transferee respectively. **9.** Any rights and remedies of an assignee or transferee of a policy of life insurance under an assignment or transfer effected prior to the commencement of the Insurance Laws (Amendment) Act, 2015 shall not be affected by the provisions of this section. **10.** Notwithstanding any law or custom having the force of law to the contrary, an assignment in favour of a person made upon the condition that — (a) the proceeds under the policy shall become payable to the policy-holder or the nominee or nominees in the event of either the assignee/or transferee predeceasing the insured; or (b) the insured surviving the term of the policy, shall be valid: Provided that a conditional assignee shall not be entitled to obtain a loan on the policy or surrender a policy. **11.** In the case of the partial assignment or transfer of a policy of insurance under sub-section (1), the liability of the insurer shall be limited to the amount secured by partial assignment or transfer and such policy-holder shall not be entitled to further assign or transfer the residual amount payable under the same policy.

## **Annexure 4**

### **Section 39 “Nomination by Policyholder” is reproduced below**

The holder of a policy of life insurance on his own life may, when effecting the policy or at any time before the policy matures for payment, nominate the person or persons to whom the money secured by the policy shall be paid in the event of his death: Provided that, where any nominee is a minor, it shall be lawful for the policy-holder to appoint any person in the manner laid down by the insurer, to receive the money secured by the policy in the event of his death during the minority of the nominee. **2.** Any such nomination in order to be effectual shall, unless it is incorporated in the text of the policy itself, be made by an endorsement on the policy communicated to the insurer and registered by him in the records relating to the policy and any such nomination may at any time before the policy matures for payment be cancelled or changed by an endorsement or a further endorsement or a will, as the case may be, but unless notice in writing of any such cancellation or change has been delivered to the insurer, the insurer shall not be liable for any payment under the policy made bona fide by him to a nominee mentioned in the text of the policy or registered in records of the insurer. **3.** The insurer shall furnish to the policyholder a written acknowledgment of having registered a nomination or a cancellation or change thereof, and may charge such fee as may be specified by regulations for registering such cancellation or change. **4.** A transfer or assignment of a policy made in accordance with section 38 shall automatically cancel a nomination: Provided that the assignment of a policy to the insurer who bears the risk on the policy at the time of the assignment, in consideration of a loan granted by that insurer on the security of the policy within its surrender value, or its



re-assignment on repayment of the loan shall not cancel a nomination, but shall affect the rights of the nominee only to the extent of the insurer's interest in the policy: Provided further that the transfer or assignment of a policy, whether wholly or in part, in consideration of a loan advanced by the transferee or assignee to the policy-holder, shall not cancel the nomination but shall affect the rights of the nominee only to the extent of the interest of the transferee or assignee, as the case may be, in the policy: Provided also that the nomination, which has been automatically cancelled consequent upon the transfer or assignment, the same nomination shall stand automatically revived when the policy is reassigned by the assignee or retransferred by the transferee in favour of the policy-holder on repayment of loan other than on a security of policy to the insurer. **5.** Where the policy matures for payment during the lifetime of the person whose life is insured or where the nominee or, if there are more nominees than one, all the nominees die before the policy matures for payment, the amount secured by the policy shall be payable to the policy-holder or his heirs or legal representatives or the holder of a succession certificate, as the case may be. **6.** Where the nominee or if there are more nominees than one, a nominee or nominees survive the person whose life is insured, the amount secured by the policy shall be payable to such survivor or survivors. **7.** Subject to the other provisions of this section, where the holder of a policy of insurance on his own life nominates his parents, or his spouse, or his children, or his spouse and children, or any of them, the nominee or nominees shall be beneficially entitled to the amount payable by the insurer to him or them under sub-section (6) unless it is proved that the holder of the policy, having regard to the nature of his title to the policy, could not have conferred any such beneficial title on the nominee. **8.** Subject as aforesaid, where the nominee, or if there are more nominees than one, a nominee or nominees, to whom sub-section (7) applies, die after the person whose life is insured but before the amount secured by the policy is paid, the amount secured by the policy, or so much of the amount secured by the policy as represents the share of the nominee or nominees so dying (as the case may be), shall be payable to the heirs or legal representatives of the nominee or nominees or the holder of a succession certificate, as the case may be, and they shall be beneficially entitled to such amount. **9.** Nothing in sub-sections (7) and (8) shall operate to destroy or impede the right of any creditor to be paid out of the proceeds of any policy of life insurance. **10.** The provisions of sub-sections (7) and (8) shall apply to all policies of life insurance maturing for payment after the commencement of the Insurance Laws (Amendment) Act, 2015. **11.** Where a policy-holder dies after the maturity of the policy but the proceeds and benefit of his policy has not been made to him because of his death, in such a case, his nominee shall be entitled to the proceeds and benefit of his policy. **12.** The provisions of this section shall not apply to any policy of life insurance to which section 6 of the Married Women's Property Act, 1874, applies or has at any time applied: Provided that where a nomination made whether before or after the commencement of the Insurance Laws (Amendment) Act, 2015, in favour of the wife of the person who has insured his life or of his wife and children or any of them is expressed, whether or not on the face of the policy, as being made under this section, the said section 6 shall be deemed not to apply or not to have applied to the policy.

## **Annexure 5**

### **Section 45 "Policy not to be called in question on ground of misstatement after three years" is reproduced below**

**1.** No policy of life insurance shall be called in question on any ground whatsoever after the expiry of three years from the date of the policy, i.e., from the date of issuance of the policy or the date of commencement of risk or the date of Revival of the policy or the date of the rider to the policy, whichever is later. **2.** A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of Revival of the policy or the date of the rider to the policy, whichever is later, on the ground of fraud: Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or assignees of the insured the grounds and materials on which such decision is based. Explanation I- For the purposes of this sub-section, the expression "fraud" means any of the following acts committed by the insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy: a. the suggestion, as a fact of that which is not true and which the insured does not believe to be true; b. the active concealment of a fact by the insured having knowledge or belief of the fact; c. any other act fitted to deceive; and d. any such act or omission as the law specifically declares to be fraudulent. Explanation II- Mere silence as to facts likely to affect the assessment of the risk by the insurer is not fraud, unless the circumstances of the case are such that regard being had to them, it is the duty of the insured or his agent, keeping silence to speak, or unless his silence is, in itself, equivalent to speak. **3.** Notwithstanding anything contained in sub-section (2), no insurer shall repudiate a life insurance policy on the ground of fraud if the insured can prove that the mis-statement of a or suppression of a material fact was true to the best of his knowledge and belief or that there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of a material fact are within the knowledge of the insurer: Provided that in case of fraud, the onus of disproving lies upon the beneficiaries, in case the policyholder is not alive. Explanation –A person who solicits and negotiates a contract of insurance shall be deemed for the purpose of the formation of the contract, to be the agent of the insurer. **4.** A policy of life insurance may be called in question at any time within three years from the date of issuance of the policy or the date of commencement of risk or the date of Revival of the policy or the date of the rider to the policy, whichever is later, on the ground that any statement of or suppression of a fact material to the expectancy of the life of the insured was incorrectly made in the proposal or other document on the basis of which the policy was issued or revived or rider issued: Provided that the insurer shall have to communicate in writing to the insured or the legal representatives or nominees or assignees of the insured the grounds and materials on which such decision to repudiate the policy of life insurance is based: Provided further that in case of repudiation of the policy on the ground of misstatement or suppression of a material fact, and not on ground of fraud, the premiums collected on the policy till the date of repudiation shall be paid to the insured or the legal representatives or nominees or assignees of the insured within a period of ninety days from the date of such repudiation. Explanation- For the purposes of this sub-section, the mis-statement of or suppression of fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer, the onus is on the insurer to show that had the insurer been aware of the said fact no life insurance policy would have been issued to the insured. **5.** Nothing in this sections shall prevent the insurer from calling for proof of age at any time if he is entitled to do so, and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof that the age of the life assured was incorrectly stated in the proposal.
